Right to erasure of data

Ordina will erase your data without unreasonable delay. Fill in the reason(s) that apply:

Right to data portability

Right to object

You have the right to object, on grounds relating to your particular situation, to the processing of your personal data if they are processed on legitimate grounds, in the exercise of official authority or in the public interest.

Ordina will only cease the processing of your personal data if it cannot demonstrate compelling legitimate grounds for the processing which override your interests, rights and freedoms or if those grounds are related to the establishment, exercise or defence of legal claims.

After receiving this form, Ordina will process the request and depending on the complexity of your request and the number of requests that period, Ordina will respond within one month after receiving the request, which can be extended by two months, if required. In such case, Ordina will inform you.

If Ordina does not take action on your request, Ordina will inform you within one month of receipt of your request, stating the reasons for not taking action. Ordina will also inform you about the possibility of (i) lodging a complaint to a supervisory authority or (ii) seeking a judicial remedy.

4. Proof of your identity

As proof of your identity, please attach a copy of your ID card to this form. Make sure you cover your citizen service number (*Burger-servicenummer* - BSN) or you can use *KopieID app* to make a secure copy. If, however, Ordina has reasons to doubt your identity, it is entitled to ask you for additional information to confirm your identity.

By signing this form, I, the applicant, declare that the information provided on this form is correct and to be the person concerned in whose name the form is located. I understand that Ordina must confirm my identity and that I may be contacted before Ordina can respond to my request. I also understand that my request is invalid until all requested information has been received by Ordina. I understand that although a request should be free of charge, in case I put in the request for the second time or in case I make unfounded/excessive requests, Ordina may charge me a reasonable administrative fee to process my request.
